**VOLUNTARY RELEASE, WAIVER, ASSUMPTION OF RISK  
AND FULL INDEMNITY AGREEMENT**

The undersigned participant requests permission to participate in the Wellsville City Founder's Day Youth Rodeo.

In consideration of permission to so participate, the undersigned hereby agrees as follows:

1. The undersigned hereby **fully releases** and **fully discharges** Wellsville City Corporation, and its officers, employees, agents, managers, attorneys, representatives, successors and assigns (hereinafter collectively referred to as "Releasees") from any claim, liability and/or responsibility for any and all personal or bodily injuries, including death, property damages, loss or inconvenience of any kind and any other type or kind of injury, and/or loss and/or damages, that may be suffered by the undersigned and which arises out of, results from or is associated in any way with the undersigned's participation in the referenced youth rodeo and of and from any claim, liability and/or responsibility of any kind that may arise while said youth rodeo is being conducted insofar as the undersigned is concerned. The undersigned further hereby **fully waives** all rights and claims against Releasees to the same extent as here in this paragraph provided; and further **covenants not to sue** said Releasees in connection with or related to any such claim, liability and/or responsibility as here in this paragraph provided. The undersigned hereby **covenants to hold Releasees harmless from and to fully indemnify** Releasees for and against any and all claims from any person or entity for the payment of any type or kind of damages, judgments, awards, or related expenses, including, but not limited to, attorneys fees and court costs, that Releasees may incur as a result of the participation by the undersigned in any activity of the referenced youth rodeo.

2. The undersigned verifies that he/she is physically fit and fully capable of participating in the activities of the youth rodeo.

3. The undersigned **ACKNOWLEDGES AND UNDERSTANDS** that there are **INHERENT DANGERS AND RISKS** in participating in any and all rodeo activities, including those of the referenced youth rodeo. With the foregoing in mind and by signing this Agreement, the undersigned voluntarily elects to accept full responsibility for such inherent risks and dangers, which include, but are not limited to, the unpredictable and unanticipated actions and reactions of the rodeo livestock. **THE UNDERSIGNED HAS READ THIS DOCUMENT CAREFULLY AND FULLY UNDERSTANDS EACH AND ALL OF ITS TERMS. THE UNDERSIGNED UNDERSTANDS THAT IT IS A RELEASE AND WAIVER OF ALL CLAIMS, AN ASSUMPTION OF ALL RISKS AND A FULL INDEMNITY AGREEMENT. THE UNDERSIGNED VOLUNTARILY SIGNS HIS/HER NAME EVIDENCING HIS/HER ACCEPTANCE OF THE ABOVE PROVISIONS.**

4. If any provision of this agreement is held to be illegal or invalid by a court of competent jurisdiction, such provision shall be considered severed and deleted. Such severance and deletion shall not effect the validity of the remaining provisions of this agreement which shall remain in full force and effect.

5. It is the intent of the undersigned that this Voluntary Release, Waiver, Assumption of Risk and Full Indemnity Agreement, and all provisions of it, shall be binding upon the undersigned, and the undersigned's successors, heirs, personal representatives and assigns.
