TEMPORARY CENSUS JOBS

Temporary Census Workers are needed for both Cache and Rich counties. The jobs entail taking surveys to residences, updating data, follow-up survey work and related duties as needed. There are openings for Census Takers, Crew Leaders, Crew Leader Assistants, Recruiting Assistants, and Census Clerks. These are temporary jobs and you can work part-time or full-time. Evening, weekend and daytime work is available. Starting dates vary, starting in March and go through May of 2010. Duration will vary depending on work available. Most jobs will finish by July 2010. Pay is from \$9.25 to \$13.00 per hour. Applicants must have good communication skills, a valid driver's license, and your own transportation. In addition to English, other languages would be helpful. Applicants take a 28 question test and employer will conduct a background check. RABIES CLINIC DATE

FROM 10:00 a.m. to 12:00 p.m.

We will be holding the clinic next door to the City Office at 79 East Main. The rabies vaccination will cost \$15. One check may be issued for both the rabies shot and the dog license. Please make checks payable to "Wellsville City Corporation."

2010 DOG LICENSING

It's time to purchase dog tags for 2010. All dogs are required to be licensed, whether they are indoor or outdoor pets. License fees are \$5.00 for dogs that are spayed/neutered, or \$10.00 for dogs that are unaltered. (You must provide a spaying/neutering certificate to purchase the \$5.00 license.) All dog owners must provide proof of a current rabies vaccination for each dog. After March 31st, 2010 the fees for dog tags will triple, so don't procrastinate. If you have three or more dogs, contact the City Office for approval of a kennel license.

MAIL RENEWAL DOG LICENSING

(Renewal forms must reach the City Office by the deadline of March 31, 2010)

1. Fill out the renewal form provided below and return. Use a separate form for each dog. (if you have three or more dogs, please come into the city office for licensing.)
2. Enclose a copy of the current rabies certificate for each dog. The vaccination must be good through 12-31-2010 (The certificate will be returned to you.)
3. Enclose the spay-neuter certificate if applicable.
4. Enclose a check made payable to "Wellsville City Corporation" for the correct amount. Please make a separate check for utility payments!
5. The 2010 dog tag, certificates, and receipts will be mailed back to you within 2 weeks.
