RABIES CLINIC

SATURDAY, FEBRUARY 25, 2012

79 EAST MAIN

FROM 10:00 A.M. TO 12:00 P.M.

The city will be holding a rabies clinic next door to the City Office at 79 East Main. The rabies vaccination will cost \$15.00. One check may be issued for both the rabies shot and the dog license. Please make check payable to "Wellsville City Corporation."

2012 DOG LICENSING

It's time to purchase dog tags for 2012. All dogs are required to be licensed, whether they are indoor or outdoor pets. License fees are \$5.00 for dogs that are spayed/neutered, or \$10.00 for dogs that are unaltered. (You must provide a spaying/neutering certificate to purchase the \$5.00 license.) All dog owners must provide proof of a current rabies vaccination for each dog. After March 31st, 2012 the fees for the dog tags will triple, so don't procrastinate. If you have three or more dogs, contact the City Office for approval of a kennel license. You may also renew by mail, see additional information included on reverse.

STORMWATER

As snow piles up in the winter, we often turn to salt to melt snow and ice. Excess salt can seep into groundwater and stormwater runoff. Effective ice control can help prevent excess salt runoff to our waterways. There are many alternatives to salt, including potassium chloride, calcium chloride and magnesium acetate. Most can be found in hardware stores under various trade names, so check the label for chemical content. While these alternatives can be spread in a dry form or sprayed as a liquid, their best use occurs when they are used with salt. They tend to increase the efficiency of salt thereby reducing the amount that needs to be applied.

COMMUNITY EMERGENCY RESPONSE TEAM

Wellsville City is joining with the Cache County Sheriff's Office and the Cache County Response Team (CERT) Council to offer an 8-week course for people interested in learning how to take care of themselves, their families, and their communities in an emergency.

There is no fee for the course, however training material and supplies (manual, ID Card, instruction material, and basic CERT kit) will cost approximately \$50.00. Wellsville City will reimburse city residents who successfully complete this course (requires attending all 8 classes and the simulated emergency). For more information, contact City Council member Ron Case at 245-4021. Pre-registration is required. Class size is limited.

Dates: Thursdays beginning March 8, 2012 and ending May 3, 2012 (no class will be held during week of Spring Break)

Time: 6:30 p.m. (each class lasts for approximately 2-1/2 hours)

Location: Cache County Sheriff's Office, 3rd Floor 1225 West Valley View Highway, Logan

Ages: 18 years and older.

Course Schedule: Disaster Preparedness, Medical 1, Medical 2, Fire Safety and Suppression, SEARCH and Rescue, Disaster Psychology, CERT Organization & Terrorism, Review

In addition to the weekly training, the course ends with a simulated emergency held at the Logan City Fire Department Training Tower. This will give participants an opportunity to put their training to use. This date for the simulated emergency will be announced later but will be some time in May.

Everyone in the community would benefit in receiving this training. CERT Training provides important information and skills for people of all ages and physical capabilities. The Mayor and City Council encourages you to give serious consideration in attending these valuable classes.

2011 DOG LICENSING

MAIL RENEWAL DOG LICENSING

(Renewal forms must reach the City Office by the deadline of

March 31, 2012)

1. Fill out the renewal form provided below and return. Use a separate form for each dog. (If you have three or more dogs, please come into the city office for licensing.)
2. Enclose a copy of the current rabies certificate for each dog. The vaccinations must be good through 12-31-2012 (The certificate will be returned to you.)
3. Enclose the spay-neuter certificate if applicable.
4. Enclose a check made payable to "Wellsville City Corporation" for the correct amount. Please make a separate check for utility payments!
5. The 2012 dog tag, certificates, and receipts will be mailed back to you within 2 weeks.

ANIMAL CONTROL

Please be aware that dogs must be under physical control at all times, whether on a leash, chain, or in an enclosure. Our animal control officer is actively patrolling for dogs that are running loose, and he has been issuing citations and impounding stray dogs. If you have an animal control concern, you may reach our animal control officer, Kirt Lindley at 512-6658.
