

WELLSVILLE FOUNDER'S DAY BOOTH APPLICATION

Welcome to Wellsville City's celebration! The annual event is held on Labor Day (always the first Monday in September). Applications for booths are accepted June 1st through Aug 31st. Booth size is 12 ft. x12 ft. Booths are located on the grassy area north of the Historic Wellsville Tabernacle located at 75 S 100 E. Your names and booth assignments will be listed on a map located at the southeast corner of the pavilion. Booth hours are 9 a.m. to 4 p.m. Please unload and move your vehicle off of the grass. Vendor Requirements:

1. No one is permitted to sell or display merchandise or set up a booth without first completing this form.
2. Wellsville City (the City) reserves the right to restrict and/or regulate the sale or display of any or all items offered in conjunction with the Wellsville Founder's Day Celebration.
3. It is the responsibility of the seller to collect Utah State sales tax on all items sold and submit the proper paperwork and taxes collected to the Utah State Tax Commission.
4. Vendors are responsible for providing their own liability insurance. Each vendor shall hold the City harmless from and indemnify the City against any injury that may occur in the vendor's space.
5. The City reserves the right to restrict the number of vendors selling similar items but cannot guarantee there will be no duplicate products for sale. Applications will be accepted on a "first come, first served" basis. There will be no guarantee on location.
6. The City shall not be responsible or liable to the seller for any loss or damage that may result in the seller's property from water, fire, explosion, theft or any other cause whatsoever.
7. All fees are non-refundable.
8. Vendors selling food items must comply with all health regulations as determined by the Bear River Health Department. BRHD or the City has the right to shut down any vendor who the City or Health Dept. sees posing a health risk to the public.
